### WHAT IS THIS RESOURCE LIST?

The National Prisoner Resource List (NPRL) provides information about organizations that support people in prison and their loved ones. The NPRL is published by Prison Book Program in Quincy, MA, one of dozens of books to prisons programs across the country.

### WHAT IS THE PRISON BOOK PROGRAM?

Prison Book Program is a nonprofit founded in 1972 that supports people in prison by sending free books and reading material that meet their needs and interests. We have a small staff and are supported by thousands of volunteers and generous donors.

# HOW DO I REQUEST BOOKS FROM PRISON BOOK PROGRAM?

Write us a letter that includes the following:

- Name as known to the DOC (no nicknames)
- ID number
- Full mailing address
- Any book restrictions that your facility has
- 3-4 subjects that interest you

If you include requests for multiple people in the same envelope, please put each person's request on a separate piece of paper.

You **do not** need to send any money, postage, or stamps in order to request or receive books. However, if you send money or stamps, it will be gratefully received as a donation to help our program continue and expand.. Please ensure that checks are made out to Prison Book Program (the legal name of our organization.)

### WHO CAN REQUEST BOOKS?

Anyone in any prison or jail facility in the US or its territories can request books! PBP serves prisons in all 50 states, Puerto Rico, and Guam. If your facility allows books from PBP, we will send some. However, please know that many facilities do not consider PBP an approved book vendor.

We currently do not send books to state facilities in MI and TX.

Limit 3 shipments per person per year. Turn to page 4 for a list of other programs that send free books to people in prison and write to them as well!

Loved ones on the outside can fill out a book request on behalf of someone in prison by going to our website, www.prisonbookprogram.org.

### Where does the name Lucy Parsons Bookstore come from?

Our bookstore is named after an important historical figure, a labor organizer and public speaker named Lucy Parsons. Lucy Parsons was born to an enslaved woman in Virginia in 1851. Her father may have been their enslaver, and he moved mother and child to Texas in 1863 to avoid having to emancipate them. Lucy married Albert Parsons, a white man, in 1872 and together they fled the racial terror of Texas for Chicago. The couple became highly effective labor organizers and prominent anarcho-socialists. They were instrumental in organizing the "wage slaves" of Chicago's sprawling factories to strike for an 8-hour work day, among other causes. Albert was executed in 1887 for conspiracy in the Haymarket Riot, a charge widely regarded as a frame-up. Lucy regarded Albert as a martyr and maintained a rigorous

schedule of public speaking, demonstrating, and advocating for workers' rights into her nineties. The Chicago police called Lucy "more dangerous than a thousand rioters."

Lucy's legacy lives on in the Lucy Parsons Bookstore and Center in Jamaica Plain, which once provided physical space to PBP and still provides important book distribution assistance.

# How do you choose the resources included in the NPRL?


There are several ways organizations get added to the NPRL.

Sometimes organizations reach out to us directly to be included. Many of our incarcerated readers reach out with updates of organizations that are not responding, or new additions that they don't see listed. Because we serve people all over the US, PBP does not generally include in our listings organizations that serve a limited population. We try to include organizations that serve multiple or very large jurisdictions.

When we learn of a new organization, we contact them to make sure the listing includes the most up to date contact information, programs, and resources offered.

PBP has found excellent organizations that are detailed here on the following resource lists: Tranzmission Prison Project Resource List, Bar None Prisoner Resource List, Equal Justice Prisoner Resource List, American Association of Law Libraries' List of Law Libraries Serving Prisoners, Christian Pen Pals Prisoner Resource List, Inside Books Project Resource Guide, and PARC Resource List.

### WHAT HAPPENS WHEN YOU WRITE TO PRISON BOOK PROGRAM

Your letters are handled by many caring volunteers, all of whom take your requests seriously and are excited to send you quality reading material that you will enjoy.

We get 1,200-1,800 letters each month. Typically, 2-3 weeks worth of mail is put into a "batch." Every letter in the batch is opened and read, and book requests are separated from mail that does not contain book requests.

Then, volunteers called Mail Processors organize each batch of mail by facility and mark each request up with all the rules for books and packages at that facility.

Next, volunteers called Verifiers confirm your location and address to see if you've been transferred or released.

After that, your letter goes to volunteers called Pickers who comb our library to choose the best books for you. The picked books are then passed on to other volunteers called Invoicers, who write your packing slip complete with a personal note.

At that point, volunteer Packers prepare your books for the mail in precisely the way your facility requires.

The final step is done by our Quality Control volunteers, who check everything for correctness and then weigh and stamp each package.

At each step, volunteers check each other's work to ensure that we are accomplishing our goal of supporting you by providing books and resources that meet your specific needs and interests. Our goal is to get your package in the mail within 60-90 days of receiving your request.

Please know, however, that we do not keep a record of each request and its status, so we won't be able to answer questions about where in the process your books are. If you made a request and haven't received anything within 90 days, please write a new request. We don't keep files on each person and we don't have a mailing list.
